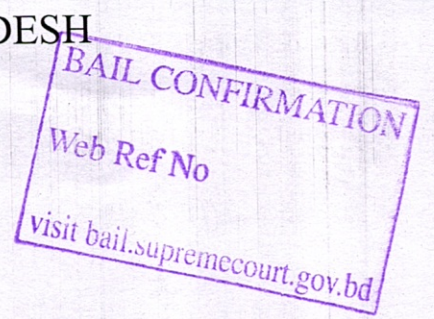

ORDER

Today the accused petitioners no. 1. Md. Ibrahim son of late Md Nurul Islam 2. Most. Shamim Ara Wife of Md. Ibrahim and 3. Most. Anna Begum alias Iti Akhtar alias Anna Daughter of Md. Ibrhim have surrendered before this Court and prayed for anticipatory bail under section 498 of the Code of Criminal Procedure in connection with Kadomtali Police Station Case No.62 dated 18.03.2017 under section 306 of the penal Code now pending in the Court of Chief Metropolitan Magistrate, Dhaka. The accused petitioners identified by their engaged lawyer.

We have heard the learned advocate on behalf of the accused petitioners and perused the application. Considering the facts and circumstances, we are inclined to enlarge the accused petitioners on bail for a limited period.

Let the accused petitioners no.1, Md. Ibrahim, son of late Md. Nurul Islam, 2. Most, Shamim ara, wife of Md. Ibrahim and 3. Most, Anna Begum alias Iti Akhtar alias anna, daughter of Md. Ibrahim be enlarged on ad-interim anticipatory bail for a period of **8(eight)** weeks from date, subject to furnishing bail bond to the satisfaction of the Chief Metropolitan Magistrate, Dhaka.

No further extension will be given from this Court.

After expiry of the aforesaid bail period the accused petitioners will surrender before the Chief Metropolitan Magistrate. Dhaka positively. The Chief Metropolitan Magistrate, Dhaka is at liberty to consider the prayer for bail of the accused petitioners, if any, in accordance with law.

With the above directions, the application is **disposed of.**
