Bhishmadev Chakrabortty, J:

This Rule was issued on an application under section 498 of the Code of Criminal Procedure. At the time of issuing the Rule, the accused-petitioner was granted ad-interim bail for a limited period.

Mr. Mohammad Ali, learned Advocate for the petitioner submits that after releasing the petitioner on bail, he did never misuse its privilege. In support of it, the learned Advocate has filed an affidavit annexing the relevant order of the Court concerned.

Mr. KM Masud Rummy, learned Deputy Attorney General for the opposite party opposes the Rule but does not bring any allegation of misuse of bail.

We have considered the submissions of both the sides and gone through the documents on record. We find merit in this Rule.

In the result, the Rule is made absolute. Ad-interim bail granted to the accused-petitioner on 26.11.2018 is hereby confirmed.

However, the Court concerned will be at liberty to cancel the bail, if the petitioner misuses its privilege in any manner whatsoever.
