Order

Heard the contentions learned Advocate for the accused petitioner and perused the application filed under section 498 of the Code of Criminal Procedure and the annexures thereto.

The learned Deputy Attorney General vehemently opposes the prayer for bail.

Records need not be call for.

Let a Rule be issued calling upon the opposite party to show cause as to why the accused petitioner should not be enlarged on bail in Metro. Sessions Case No. 24063 of 2018 arising out of **Khilgaon** Police Station Case No.14 dated 06.09.2018, corresponding to G.R. Case No.629 of 2018, under Section 19(1) Table 9(Kha) of the Madok Drabbya Niontran Ain, 1990, now pending in the Court of **learned Additional Metropolitan Sessions Judge, 7<sup>th</sup> Court, Dhaka** and/or pass such other or further order or orders as to this Court may seem fit and proper.

Having considered the facts and circumstances of the case and materials on record, in particular, that 600 [six hundred] pieces of yaba tablet, were recovered form the possession of the accused petitioner and his duration of jail hayat, we are inclined to enlarge the accused petitioner on ad-interim bail.

Pending hearing of the rule, let the accused petitioner **Eva Begum alias Eva Sultan an alias Alo daughter of late Abul Kashem** be enlarged on ad-interim bail in the above mentioned case for a period of **6(six) months** from date on furnishing bail bond subject to the satisfaction of the **Chief Metropolitan Magistrate, Dhaka.**

The Court below is at liberty to cancel the ad-interim bail of the accused-petitioner, if he misuse the privilege of ad-interim bail in any manner, in accordance with law.

The accused petitioner is directed to file affidavit of facts upon stating the latest position of the case, if further extension of ad-interim bail is required.

The Rule is made returnable within **2(two)** weeks from date. In the meantime, office is directed to take necessary steps for making the rule ready and also place the matter before this Court for hearing.

The accused-petitioner is directed to make himself available in investigation, if required.


