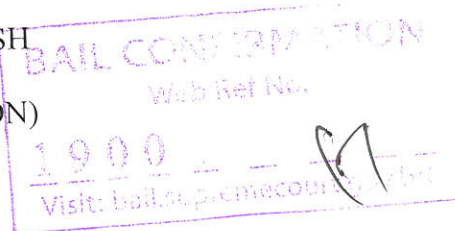

This is an application under section 498 of the Code of Criminal procedure for enlarging the accused petitioners on anticipatory bail in **Jalalabad Police Station Case No. 04 dated 03.01.2019 Corresponding to G.R. We have perused the application and heard the learned advocate for the accused petitioners and the learned Assistant Attorney General for the opposite party.

Considering the facts and circumstances of the case we are inclined to enlarge the accused petitioner on bail for a limited period.

Nurul Amin @ Atai and 15. Saddam**, be enlarged on anticipatory bail in the above mentioned Case for a period of **6 (six) weeks** on furnishing bail bond to the satisfaction of the learned Chief Metropolitan Magistrate, Sylhet.

The accused petitioners are directed to surrender before the Court of Metropolitan Sessions Judge, Sylhet within that time and the learned Metropolitan Sessions Judge, Sylhet shall dispose of the prayer for bail of the accused petitioners if any in accordance with law.

With the above observation, the application is disposed of.
