Order

Heard the learned Advocate and perused the petition for bail of the accused-petitioner under Section 498 of the Code of Criminal Procedure and the documents annexed thereto.

Let a Rule be issued calling upon the opposite party to show cause as to why the accused-petitioner should not be enlarged on bail in connection with Lohagara Police Station Case No.12 dated 04.07.2021 corresponding to G.R.No.313 of 2021 under table 10(kha) of section 36(1)/38/41 of the Madok Drabba Niyatron Ain, 2018, now pending in the Court of Chief Judicial Magistrate, Chattogram and/or such other or further order or orders passed as to this Court may seem fit and proper.

The Rule is made returnable within 4 (four) weeks from date.

Pending hearing of the Rule, let the accused-petitioner Md. Ismail son of late Mostak Ahmed alias Samsul Alam be enlarged on ad-interim bail for a period of 6(six) months on furnishing bail bond to the satisfaction of learned Chief Judicial Magistrate, Chattogram.

In any event of misuse of the privilege of bail whatsoever or in case of any exigency revealing out of merit, the Court below would be however at liberty to withdraw the privilege of bail assigning reasons thereto.

In case of any anomaly or inconsistency is detected in respect of quantity of the seized articles recovery of 2050(two thousand and fifty) pieces of yeaba tablet in consultation with the record at the time of furnishing bail bond, the concerned court is directed to inform this court for further order.

Office shall not issue any certified copy or other copy of this order to the petitioner unless requisites are put in (vide HCD Rules, Chapter IVA Rule 3(6)).
