The office shall not issue any certified copy or other copy of this order to the petitioner unless requisites are put in as per the provisions of above Rules.</p> <p>The court below is at liberty to cancel the bail of the petitioner in accordance with law, if the privilege of bail is misused by him in any manner.</p> <p>The accused-petitioner is also directed to file affidavit of facts stating the latest position of the case if further extension of bail is needed.</p> <p style="text-align: center;"><small>Shajedul/ABO</small></p>
