Pending disposal of the Rule, let the accused-petitioner Md. Abdus Samad, son of late Akimuddin, Mother: Nurjahan Ara be enlarged on ad-interim bail for 01 (one) year from date on furnishing bail bond subject to the satisfaction of the learned Chief Judicial Magistrate, Naogaon.

The Rule is made returnable within 04 (four) weeks from date.
