By filing an application, the Court-appointed Board of Directors (hereinafter referred to as the BoD) of respondent No.1- E-valy.com Limited (hereinafter referred to as the Company or E-valy) seeks certain directions from this Court upon the Governor. Bangladesh Bank and the Managing Directors of the following banks, namely, (i) The City Bank Ltd., (ii) Southeast Bank Ltd., (iii) BRAC Bank Ltd., (iv) Dhaka Bank Ltd., (v) Modhumoti Bank Ltd. & (vi) Midland Bank btd. directing them to take necessary steps to confiscate and submit to the Court, any Cheque signed by the ex-Managing Director & CEO of the respondent Company Mr. Md. Rassel and/or the ex-Chairman Mrs. Shamima Nasrin on behalf of the respondent Company, i.e. Evaly.com Ltd. if presented to those banks and, further, prays for a direction upon the Secretary. Law and Justice Division, Ministry of Law, Justice and Parliamentary Affairs and all the District and Sessions Judges, to take necessary steps regarding striking out/exclusion of the names of the court-appointed BoD. i.e. the names of the following persons, namely. (i) Mr. Justice A.H.M. Shamsuddin Chowdhury, (ii) Mr. Rezaul Ahsan, (iii) Mr. Khan Mohammad Shameem Aziz, (iv) Mr. Fakhruddin Ahmed & (v) Mr. Mahbub Kabir from all proceedings commenced under section 138 of the Negotiable Instruments Act 1881 against the respondent No.1 Company, i.e. Evaly.com Ltd. in connection with any Cheque issued by the ex-Managing Director & CEO of the respondent Company Mr. Md. Rassel and/or the ex-Chairman Mrs. Shamima Nasrin and to recall and cancel any summons and/or warrant already issued, if any, in pursuance of any of the aforesaid proceedings.

It is contended that when the Court appointed BoD is carrying out its duties as per directions passed by this Court by putting its best efforts to find out the illegalities and irregularities committed by the previous BoD and Management of the E-valy, a few unscrupulous Cheque holders which were issued by the ex-Managing Director & CEO of the E-valy (Mr. Md. Rassel and Mrs. Shamima Nasrin) (hereinafter referred to as the previous BoD) started proceeding under Section 138 of the Negotiable Instruments Act 1881 against the Court appointed Board of Directors of the respondent No.1 Company, i.e. Evaly.com Ltd., and in pursuance of some of the aforesaid proceedings, already summons

and/or warrants have been issued against the present Court appointed BoD.

Mr. Morshed Ahmed Khan, the learned Advocate for the respondent No.1 submits that present Court-appointed BoD has not issued any Cheque(s) in favour of any person/entity and, therefore, the Court-appointed BoD is not and cannot be held responsible for honoring any Cheque issued by the previous BoD. It is the humble prayer of the learned Advocate for the Court appointed BoD that until and unless appropriate Orders and Directions are passed upon the aforesaid State-Functionaries and Banks in an appropriate manner, it would be difficult for the Court-appointed BoD to run the company smoothly and effectively.

It appears from the annexed papers that on an application under Section 138 and 140 of Negotiable Instrument Act, 1881 filed by one Mr. Mosharraf Hossain in CR Case No. 132 of 2022, learned Metropolitan Magistrate (Sabujbag Amoli). Ms. Shanta Akhter has issued summons upon the Court-appointed BoD, names of whose are (i) Mr. Justice A.H.M. Shamsuddin Chowdhury, (ii) Mr. Rezaul Ahsan. (iii) Mr. Khan Mohammad Shameem Aziz, Barrister at law. (iv) Mr. Fakhruddin Ahmed and, (v) Mr. Mahbub Kabir.

Given that the Cheques were issued by the previous BoD under the signatures of ex-Managing Director & CEO of the respondent Company Mr. Md. Rassel and/or the ex-Chairman Mrs. Shamima Nasrin, and present Court-appointed BoD comprising aforesaid persons was formed by the Order of this Court vide Order dated 18.10.2021.

therefore, this Court is of the view that learned Metropolitan Magistrate (Sabujbag Amoli), Ms. Shanta Akhter ought not to have issued summons upon the present Court-appointed BoD comprising aforesaid persons. Although, it amounts to be a contemptuous Order, however, this Court is of the view that a novice Judicial Officer might not have understood the meaning of Court-appointed BoD. Accordingly, this Court is of the view that instead of summoning the learned Metropolitan Magistrate (Sabujbag Amoli), Ms. Shanta Akhter to appear before this Court in person to furnish her clarification for issuance of summons against such dignitaries who were appointed in the present BoD of E-valy vide this Court's Order, it would be fair adjudication of this application, if this Court directs the concerned learned Metropolitan Magistrate (Sabujbag Amoli), Ms. Shanta Akhter not to enforce but to return summons/warrant issued in the names of the Court-appointed Board of Directors, i.e. in the names of the aforesaid dignitaries in proceedings commenced under section 138 of the Negotiable Instruments Act 1881 against the respondent Company, i.e. Evaly.com Ltd. in connection with any Cheque issued by the ex-Managing Director & CEO of the respondent Company Mr. Md. Rassel and/or the ex-Chairman Mrs. Shamima Nasrin along with some other Orders.

Accordingly, the application is allowed with the following Directions;

(i) Learned Metropolitan Magistrate (Sabujbag Amoli). Ms.

Shanta Akhter is directed not to enforce but to return summons/warrant issued in the names of the Court-

appointed Board of Directors, i.e. in the names of the aforesaid dignitaries, namely, ; (i) Mr. Justice A.H.M. Shamsuddin Chowdhury, (ii) Mr. Rezaul Ahsan, (iii) Mr. Khan Mohammad Shameem Aziz, Barrister at law. (iv) Mr. Fakhruddin Ahmed and (v) Mr. Mahbub Kabir, in proceedings commenced under Section 138 of the Negotiable Instruments Act 1881 against the respondent Company, i.e. Evaly.com Ltd. in connection with any Cheque issued by the ex-Managing Director & CEO of the respondent Company Mr. Md. Rassel and/or the ex-Chairman Mrs. Shamima Nasrin and strike out/exclude their names from the said proceeding being C.R. Case No. 132 of 2022

- are hereby extended till disposal of this matter restraining all the creditors of the respondent Company (a) from insisting upon the Court-appointed BoD for any refund until the Court-appointed Board of Directors submits their report to the Court on the basis of the special audit which is in progress.
- (iii) The Governor, Bangladesh Bank and the Managing Directors of the following banks, namely, . (i)The City Bank Ltd., (ii) Southeast Bank Ltd., (iii) BRAC Bank Ltd., (iv) Dhaka Bank Ltd., (v) Modhumoti Bank Ltd. & (vi) Midland Bank Ltd. are directed to notify the Cheques

holders that before placing any Cheque signed by the ex-Managing Director & CEO of the respondent Company Mr. Md. Rassel and/or the ex-Chairman Mrs. Shamima Nasrin on behalf of the respondent Company. i.e. Evaly.com Ltd, if presented to those banks, the Cheques holders are required to approach the Company Court first.

- (iv) The Secretary, Law and Justice Division, Ministry of Law. Justice and Parliamentary Affairs and all the District and Sessions Judges of Bangladesh are directed to take necessary steps regarding striking out/exclusion of the names of the present court-appointed Board of Directors. namely, (i) Mr. Justice A.H.M. Shamsuddin Chowdhury. (ii) Mr. Rezaul Ahsan, (iii) Mr. Khan Mohammad Shameem Aziz, Barrister at law, (iv) Mr. Fakhruddin Ahmed and, (v) Mr. Mahbub Kabir from all proceedings commenced under Section 138 of the Negotiable Instruments Act 1881 against the respondent Company, i.e. Evaly.com Ltd. in connection with any Cheque issued by the ex-Managing Director & CEO of the respondent Company Mr. Md. Rassel and/or the ex-Chairman Mrs. Shamima Nasrin and to recall and cancel any summons and/or warrant already issued, if any, in pursuance of any of the aforesaid proceedings:
- (v) The Secretary, Ministry of Home Affairs and the Inspector General of Police are directed to take necessary steps not

The office is directed to serve notices upon the following state functionaries, namely, (i) The Secretary, Ministry of Home Affairs, (ii) The Inspector General of Police, (iii) The Secretary. Law and Justice Division. Ministry of Law, Justice and Parliamentary Affairs, (iv) District and Sessions Judge of Dhaka, (v) Learned Metropolitan Magistrate (Sabujbag Amoli), Ms. Shanta Akhter, (vi) The Governor, Bangladesh Bank and the Managing Directors of the following banks, namely, (i)The City Bank Ltd., (ii) Southeast Bank Ltd., (iii) BRAC Bank Ltd., (iv) Dhaka Bank Ltd., (v) Modhumoti Bank Ltd. & (vi) Midland Bank Ltd. at once by a Special Messenger at the costs of the respondent No.1-company.

The respondent No.1-company is directed to put in requisites for service of notices.

Further, the Registrar, High Court Division is directed to circulate this Order upon all the District and Sessions Judges of Bangladesh in addition to publish this Order in the website of Supreme Court of Bangladesh.
