Let a Rule be issued calling upon the contemnors-respondents to show cause as to why a proceeding of contempt of Court should not be drawn up against them for not complying with the judgment and order dated 24.08.2022 passed by this Court in writ petition No. 7911 of 2021 with writ petition No. 8225 of 2021 And why the contemnors-respondents should not be punished accordingly and/or pass such other or further order or orders as to this Court may seem fit and proper.

The Rule is made returnable within 04(four) weeks.

Subject to disposal of the Rule, the contemnor-respondents are hereby directed to maintain status-quo in respect of appointment of 03(three) Sub-Assistant Engineer for a period of 01(one) month from date.

The contemnor-respondent No.3, namely, Abdullah Al Mamun, Controller of Examination (Non-Cadre), Bangladesh Public Service Commission, Bangladesh Public Service Commission Secretariat, Agargaon, Sher-E-Bangla Nagar, Dhaka is directed to appear in person before this Court on 09.08.2023 at

The office is directed to serve notices upon the contemnor-respondents by usual course as well as by registered post with acknowledgment due at the cost of the petitioner.

The petitioners are directed to put in requisites for service of notices upon the respondent by registered post as well as through usual process within 03(three) working days.
